MEMBERSHIP RULES

A - CATEGORIES :

- 1) **Red Ribbon** : Chef with 5 years of experience minimum directing a kitchen, an establishment as Restaurant or Hotel with a Cooking Diploma and must show regarding his professional carrier, his implication of development of the French Cuisine or International Cuisine
- 2) **Purple Ribbon** : Sommelier and Restaurant and Hospitality Industry Employee and Wine Industry ("non-culinary professional") ; Employee or Owner of the Hospitality Industry ("**outside**" of the kitchen), like Maître d'Hôtel or Chef de Rang, Sommelier. Also all the professional category of persons related to the Wine Industry. Must show regarding his professional carrier, his implication and interest in the Gastronomy. Must be introduce by "Disciple Escoffier Red Ribbon" or "Disciple Escoffier purple Ribbon"
- 3) **Blue Ribbon** : "Epicurean" (non-Hospitality Industry Professional) ; Person who has strong interest in the entire world of Gastronomy, but who is not a professional of Culinary Industry ; must be introduce by a "Disciple Escoffier Red Ribbon" or "Disciple Escoffier Purple Ribbon"
- 4) **Green Ribbon**: Representatives of organizations or companies that are related to the culinary trade and are without voting rights. Each organization or company is eligible to send not more than 2 representatives per event to the gatherings of the Association.
- 5) **Honorary Member & Beneficiary** ; Honorary Members are nominated by the APAC Chairman Board ; Honorary members named by the APAC Chairman Board can be Local, Regional, and French or Foreign nationalities ; a Beneficiary Members is a person and/or a Corporate who is not actively participating into the Association but who is giving one or several donations to the Association.

B – IN ORDER TO BECOME AN ACTIVE MEMBER OF THE ASSOCIATION, YOU MUST :

- 1°) Be major and enjoy all civil rights
- 2°) Be domiciled and/or be able to exercise one's professional activity in one of the delegations of Asia Pacific
- 3°) Agree with the present Status and Rules of the Association
- 4°) Show your interest in Gastronomy, Hotel and Tourism Industries
- 5°) Engage yourself into the realization of objectives and events pursued by the Association and not use your Membership for personal or lucrative ends
- 6°) Formulate in writing, an application for admission, signed by yourself and followed by the signatures of two Members and/or active Members of the Association
- 7°) Be authorized by the Mother Association, represented by its Board of Governors, in which the decision in the matter is discretionary and not prompted

C – THE MEMBERSHIP STATUS CAN BE STOPPED BY :

- 1°) The notified resignation through a registered letter with acknowledged receipt or by a letter given directly by the Association's President
- 2°) The death of actual Member
- 3°) The disability of the Member or for personal judicial matters
- 4°) The exclusion by Disciples Escoffier International Board (World Association) or by the APAC Chairman Board, for serious matters such as offences to the present Status or the Association's Rules, or, by not paying annual fees (the concerned party having beforehand been invited to offer his or her means and explanations)
